


## **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 2102.5 tCO₂e by 2026. This is a reduction of 50%

**Completed Carbon Reduction Initiatives** 

- Our environmental management system certified to ISO 14001
- All waste generated is recycled where possible to reduce landfill.
